Camp Golden Pond Rental Agreement

Upon acceptance by our office and payment of all rental fees in full, this Agreement is made for _____ (date of rental) between Friends of Golden Pond (“FGP”) and your organization or Scouting group (“Organization”), on the dates listed on the reverse side for Organization’s use of FGP facilities at Camp Golden Pond.

In consideration of FGP permitting Organization to use FGP premises, and intending to be legally bound, Organization hereby agrees as follows:

1. Organization, on behalf of itself, its members, agents, visitors, guests, and employees agrees to abide by all of the terms of this agreement. Rental fee for use of the requested facilities as listed and shall be paid in full upon reservation.
2. Organization, on behalf of itself, its members, agents, visitors and employees hereby releases, and hereby covenants and agrees to indemnify, defend and hold harmless, FGP, its directors, officers, volunteers, agents and employees, from all liabilities and claims for damages and/or suits, charges, expenses (including counsel fees) and costs for or by reason of any injury or injuries to any person or persons or property of any kind whatsoever from any cause or causes whatsoever while Organization is in or upon FGP premises during the term of this Agreement, or occasioned by any occupancy or use of FGP premises or any activity carried on by the Organization in connection therewith, however occurring, and whether or not caused in part by a party indemnified hereunder.
3. Organization shall submit a certificate of insurance to FGP. FGP reserves the right to require additional insurances or higher limits of coverage, or to grant an exemption, depending on the nature of the event.
4. Organization agrees to follow all applicable FGP policies. In particular, if the Organization’s activity shall involve minors, Organization certifies that the Officer whose signature appears on this document has read [Guide to Safe Scouting - <http://www.scouting.org/scoutsource/HealthandSafety/GSS/toc.aspx>] and the Organization has complied with all relevant aspects of that Policy and Pennsylvania Child Protection Laws (www.KeepKidsSafe.pa.gov).
5. The FGP has the right to terminate Organization’s use of FGP premises if, in the sole discretion of FGP, such use would interfere with operation of the FGP, or if the event cannot be held by reason of fire, flood, acts of God, strikes, labor disturbances, or other events beyond the control of the FGP. The Organization agrees to release, hold harmless and defend the FGP from any costs, including legal fees, due to the FGP’s termination of Organization’s use of FGP premises.
6. This Agreement shall be governed by the laws of the Commonwealth of Pennsylvania. The Organization hereby agrees to be subject to the jurisdiction of the courts for the County of Centre, Pennsylvania and agrees further that Centre County shall be the venue for any and all legal actions brought under this Agreement.
7. Possession or use of Alcohol at Camp Golden Pond during this rental is NOT Permitted and will result in immediate expulsion from FGP property and loss of any rental fees.
8. **Additional terms of rental:**
 - **FGP shall:** Have the rented facilities clean and ready for habitation on the rental date as agreed upon.
 - **FGP shall:** If the entire camp is being rented - all facilities and buildings are in use by the “Organization” - the camp should be considered “private” for the duration of the rental and posted as such.
 - **FGP shall:** If previously arranged – meals and or food as agreed upon. Such charges will be considered above and beyond the rental fees and terms will be covered under separate agreement.
 - **Organization shall:** Pay for any damage to the property, its buildings and contents as identified.
 - **Organization shall:** Leave campground in same condition as it was found.

Changes to this agreement must be acknowledged in writing by both parties before it is considered binding. All verbal agreements are considered null and void.
